PUBLIC NOTICE OF HEARING ON PLAINTIFF'S MOTION FOR SEALING ORDER

Pursuant to Texas Rule of Civil Procedure 76a(3), Plaintiff Martha Cramer, posts this Public Notice of hearing in open court on Plaintiff's Motion for Sealing Order pertaining to Plaintiff's Motion to Compel Defendant's Second Requests for Production in the above-styled case. The hearing will be held on **April 22, 2024** at **1:30pm** at the Tom Vandergriff Civil Courts Building, 100 N. Calhoun St, 3rd Floor, Fort Worth, Texas 76196.

The nature of the case is a claim for personal injury arising out of an incident on June 25, 2022, in which Plaintiff Martha Cramer was allegedly tripped by an employee of Defendant American Airlines at the Dallas Fort Worth International Airport.
