Any person may intervene and be heard concerning the sealing of the records.

The Motion seeks to seal exhibits and related testimony that may be admitted at the upcoming trial in this matter that relates to Defendants' sensitive and proprietary business information, including confidential information related to (1) the structure and governance of certain Defendants; (2) the terms and conditions of

compensation offered to certain Defendants' employees; (3) information concerning Defendants' reserves, finances, and debt over time; and information concerning other employees' compensation while employed by Defendants.

The materials sought to be sealed are relied upon by both Plaintiff and Defendants in this case and are related to Plaintiff's claims that he is owed, due to an alleged oral agreement, compensation in the form of management incentive units (or "MIUs"), which are akin to stock options.
